102nd MEETING OF THE NCWM LAW AND REGULATIONS COMMITTEE PROCEEDINGS AND VOTING SUMMARY

Louis H. Sakin, NEWMA Representative to L&R Committee

The NCWM L&R Committee had a lengthy agenda for consideration during the Open Hearings with much discussion and debate on many of the items. NEWMA was fortunate to have all of its L&R Committee members present during these proceedings. Ethan Bogren of Westchester County New York, L&R At-large Member was selected to be the new L&R Chair for 2017-2018. Details on each agenda item can be found on the NCWM website under the Publication 16 link.

The following items were approved on the Consent Agenda during the voting session:

102nd MEETING OF THE NCWM LAW AND REGULATIONS COMMITTEE PROCEEDINGS AND VOTING SUMMARY (cont'd)

The next groups of items were approved individually during the L&R voting session:

NIST HANDBOOK 130

2302-2 Section 1.12 Ready to Eat Food

2302-6 Section 2.17 Precious Metals

NIST HANDBOOK 133

2600-4 Section 4.5 Polyethylene Sheeting Bags and Liners

Items 2302-7 and 2307-2 concerning oxygenate blends and ethanol flex fuels were removed from the voting agenda by the L&R Committee and returned to FALS for further action and will remain Information items until the 2018 NCWM Interim Meeting. Item 2302-1 concerning food and non-food products did not receive sufficient votes to pass and was returned to the L&R Committee. Item 2302-5 polyethylene bags was downgraded during committee deliberation from Voting to Informational to allow more work to be completed. It did not affect the NIST Handbook 133 item on method of testing which did pass.

Other items contained in the Publication 16 Agenda which were Informational, Developing or Withdrawn did not change status. Items which did not pass during the voting session or were removed from the voting agenda as well as items which are Informational or Developing will carry over to the fall 2017 regional meetings and appear in the NCWM Publication 15 for the 2018 Interim meeting.

NEWMA Specifications and Tolerances Committee 2017 Interim Meeting

In this year's Interim Meeting the stage is set with several important new and returning topics that will undoubtedly promote active discussion. There are currently 28 New Items on the agenda with most of them in separate related groups. Ten New Items (New Item 6 through New Item 15) are related and pertain to transfer and testing standards. These Items would add new definitions and terms to NIST handbooks.

NEWMA Specifications and Tolerances Committee 2017 Interim Meeting (cont'd)

Another New Item (New 21) is certainly desirable as it helps to combat the theft of credit card numbers. In recent years the number of credit card skimming devices has drastically increased and while it is agreed that a code to bolster security measures is a necessity, there is some discussion on exactly where the code belongs.

There has been a lot of debate during the past couple years on Developing batch items 3100-1, 3200-5 and 3600-2. These items have been refined and attendees can expect to be part of quality discussion on the topic. Attendees will also be in the best position to keep up with item 3200-3 which will have a presence in the day to day business of consumers.

Committee members include Chair, Brad Bachelder (Maine Department of Agriculture), member Jim McEnerney (Connecticut Department of Consumer Protection), associate member Kevin Mikoski (Irving Oil), and the Committee is happy to welcome member Jim Willis (New York State).

Members of the NEWMA S&T Committee hope that you will join them for the discussion of New Items and of those carrying over from the July NCWM Meeting.

The work of the PDC is designed to assist regulators and industry in professional development and training. The committee has also done significant work with Safety Awareness. The committee continues to actively solicit ideas and feedback from members on these topics on an ongoing basis.

One of the goals of the PDC is to educate jurisdictions on safety issues and to provide resources to help them implement effective safety and health management programs. Ms. Julie Quinn (MN), PDC Safety Liaison, presented a report on the results of the 2017 safety survey (from 2016 incidents), The top three causes of lost or restricted time for the second year in a row were:

- Lifting/twisting/bending 54.5% 6 incidents
- Slips/trips/falls 18.2% 2 incidents
- Vehicle accidents 18.2%, 2 incidents
